I. CALL TO ORDER

President J. Lothian called the meeting to order at 7:00 pm. The Pledge of Allegiance was said.

III. REPORTS

- A. Student Representatives Student Vanessa Jimenez reported that the winter sports teams did well. The boys' basketball team won the conference. Boys swimming also won a conference title and two of our students will be going to state. The girls' gymnastics team is also going to the state tournament. Drama Club is setting up for their show which will be in March. Because of the pandemic, there will be three shows this year as well as a live stream. Seniors are planning a senior dinner and dance, similar to prom, but awards will also take place. The student council held a penny war and raised about \$247. This money will be used for a spring activity.

- D. Athletic Director Athletic Director Mike Coolidge reported that the boys' basketball season ended on Saturday at the Regional Finals. The team was undefeated in conference and won the conference title. The girls' season has also ended. The girls' gymnastics team won sectionals and three girls are going to state this weekend in Wisconsin Rapids. Ethan Marunde, a swimmer, qualified for the state meet. Middle school girls' basketball is complete. Middle school boys' basketball is in progress and will be finishing their season around March 9th. There was no conference involvement this year for middle school

basketball. Games were scheduled with teams in the area that were willing to play. M. Coolidge said that he is working on getting games together for middle school volleyball, to start mid-March. The transition into spring sports will begin in April. Boys soccer will be playing the alternate year schedule in the spring. It is normally played in the fall. M. Coolidge also wanted to recognize the coaches and the administrators for working to have sports and supporting having spectators.

 - Dr. White reported that staff members are scheduled to receive the first dose of the COVID-19 vaccine Friday, March 5 and Saturday, March 6. Mercy Health has provided the district time slots starting at 11:00 a.m. and continuing until 3:45 p.m. The district will have to allocate about an hour of time per staff member for them to travel to Mercy, receive the vaccination and travel back to school. This is going to make it very

challenging to cover everyone's classrooms. Because of the supply issue and the fact that Mercy is vaccinating all Walworth County schools on one day, Dr. White is leery of making March 5 a half day until he knows with relative certainty that the vaccinations will be held as scheduled. The question was asked when Dr. White felt that he could make the decision. Dr. White felt that he would have the necessary information from Walworth County on Friday or Monday of this week. Discussion followed.

V. DISCUSSION ITEMS

A. Discuss Snow Day Pay for Hourly Support Staff Positions

On Tuesday, January 26, 2020 there was no school due to snow. There was a question as to if hourly staff were paid for snow days. The original decision was no, hourly staff that did not work would not be paid. Later, there was an email from Coe stating that yes, hourly employees would be paid in the case the district had a snow day. J. Lothian and Dr. White conferred and compensation hourly staff for that day. There is currently no written verbiage in the handbooks as to how snow days are to be handled for hourly staff. Since Employee handbooks are being worked on now would be the time to address the issue.

J. Lothian's opinion was that a snow day is not the fault of staff and hourly staff should be paid. He said he was not opposed to the staff member making up the hours. D. Woss agreed that hourly staff should be paid. D. Ripple was concerned that this is the second issue that has risen lately due there not being a clear district policy in writing. Discussion followed. Dr. White will have verbiage regarding how snow days are handled for hourly staff added to the handbook.

B. Discuss Survey from Williams Bay Business Association

J. Lothian introduced Jim D'Alessandro from the Williams Bay Business Association to speak about a survey that the association is sending out in June. The survey is 12 questions and is sent out to about 1100 people every five years. The response rate is high, at almost 600. The survey results are used as a tool for planning. The Business Association is looking for input regarding the question related to the district. There is a committee meeting on March 8th at 4:00 pm to discuss the questions on this year's survey. Mr. D'Alessandro invited district participation.

The Board will discuss possible questions at their Saturday work session and will provide Mr. D'Alessandro feedback.

C. COVID-19 Update / Transition from Winter to Spring Sports Season

M. Coolidge updated the Board on the transition from winter sports to spring. Currently, the Trailways Conference has not had conversations regarding spring sports since some

fall sports were moved to spring. The WIAA has also not released their spring sport guidance. Because of the way middle school volleyball is played, with multiple games going on at one time, masks will be required and there will be no spectators.

Mr. Mansky spoke regarding spring activity in the middle and high schools. The Senior class is planning on holding a senior dinner/dance instead of prom. Prom usually involves the entire high school and is sponsored by the Junior class. Because they have not been able to do any fundraising to help offset the cost of prom, ticket prices would increase to pay for the event, which the students are not in favor of. Drama club will be holding their performance mid-March. It will be held in-person with limited seating as well as livestreamed. Band & Choir performances will be held in May and will also be both in-person and livestreamed. Mr. Mansky is meeting with the Senior class on Wednesday to discuss graduation.

D. Ripple asked if there was a plan to move back to the traditional Junior Prom. Dr. White advised yes, when COVID is no longer an issue.

D. Discuss Possibility of Additional Meetings if Necessary.

Based on the ever-changing COVID-19 situation, the Board wanted to make everyone aware that there might be a need to schedule additional/emergency meetings to deal with issues that arise.
