IV. Communication and Public Comment

A. Student Report – Anna Rolfs reported that it has been a busy month for the student body. The Forensics team took part in the Conference meet that was held here on February 7th. The team placed fourth over-all with three first-placed category winners. The Sub-District meet was held on February 27th and all ten team members will be moving on to the District meet to be held on March 12, 2022. We had 147 high school students qualify for the Milwaukee Bucks 3.0 Club. This club is for students who attain a

3.0 or higher. They were awarded a certificate and the ability to purchase one Bucks game ticket and receive one ticket for free. The Honors Band performed on February 14th and their performance went well. Solo and Ensemble is coming up and will be held virtually this year. The Investment Club and the Stock Market Competition is up and running. Everyone is very excited and having fun learning about the stock market. One of our teams is currently placed third in the state. Two dances were held in the last month. The first one was the high school Snowball dance, which was well attended. A dance for middle school students was also held and was sponsored by the High School Student Council. WIAA playoffs have started. Leeza Patterson went to state for gymnastics and the boys basketball team plays in the first round on Tuesday night. The high school girls basketball team was knocked out of playoffs but they had a great season overall. The middle school volleyball season is currently underway. Student Council is working on their next blood drive which is being held on March 17th. They are also planning an Activity Night on March 25th. Drama Club also is also presenting, "I Hate Shakespeare" this weekend.

- B. Athletic Director Mr. Johnson's noted that the Boys Middle School A Team took first place in the tournament last Saturday. There will also be a send-off to state for Leeza Patterson this Friday. Dave Rowland also spoke to board giving updates regarding the football program.
- C. District Administrator Dr. White reported that most of his items were part of the agenda. He also asked the board for feedback regarding the Employee Benefit Survey that was emailed to them. He also commented on the football program staff being members of the community which is a really nice thing Dave has done.
- D. Middle/High School Principal Mr. Mansky reported that his notes were as presented. He spoke about the Bucks 3.0 Club being that 70% of high school students and 75% of middle school students qualified. A middle school incentive program was started today to support promising behavior for Forward and Aspire testing that is coming up. Moby Max was introduced to work on intervention and skills in the middle school. There will also be recognition in the commons for academics, hopefully by the April meeting.

She also reported that the format for the Forward testing has been changed at the elementary to match the format used in the middle school last year. Last Friday, Dr. Bond was approached by four fifth grade students who gave a wonderful presentation regarding toilet paper here at school Dr. Bond recommended that they include a cost analysis which they will be working on with Mr. Quinn. She hopes to have the students present to the board their findings.

- H. Discuss and Approve 3K Program

Ms. McOmber, Dr. Bond, Mrs. Frederick, and Dr. White worked through the details of a potential 3k program. It is proposed that the district opens a 3K program starting the 2022-2023 school year. Ms. McOmber shared with the board details and the results of a survey she sent via the Bulldog Bulletin and the Facebook Page. The program will be a half-day program and would be 15:1 class size with a teacher and an assistant. It would be funded through a combination of tuition charged to families and Fund 80. The staffing would be separate from our regular employees and does not need to be a certified teacher. We are working with Lakeland Little Learners to provide wrap-around services. There are still some details to work through, but board approval would allow us to begin communicating a firm plan to prospective families. Discussion followed.
