- C. District Administrator Dr. White reported that the District Administrators of Delavan, Big Foot and Williams Bay met with Larry Kirkley from Dousman Transportation, our bus company. Dousman is struggling to keep drivers and are looking to give their driver's a wage increase which would pass on some additional costs to the districts. We are currently in a five-year contract and could say no, but we are trying to support the bus company. It would be about a \$4,000 increase and they would maintain a five-year contract with us and would keep the annual increase to 2.5% for the remainder of the school year. If the board has any concerns, please let Dr. White know. Dr. White also introduced the new Middle/High School Principal, Emily Soley-Johnson to the board.
