V. Discussion Items

A. Discuss Policy 411.3 – Hazing

With recent events, Mr. Johnson suggested adding a policy on hazing. He has stressed to coaches that hazing will not be tolerated, but the administration team feels that it is a good idea to add this policy.

B. Discuss Policy 345.60 – Early Graduation

Mrs. Soley-Johnson has worked with her building leadership team to develop this policy. The district has seen an increase in the number of students expressing interest in graduating early over the past few years. Many of our neighboring districts have an early graduation policy and it is in the best interest of our students to have this policy in place.

C. Discuss Policy 345.2 – Student Honors Recognition

This policy has had some minor revisions. The primary revision was to change the Honor Roll Recognition from quarters to semesters.

D. Discuss Sunday Athletic Practices

Multiple coaches have approached Mr. Johnson to express interest in and question if they are allowed to practice on Sundays. There has been a strong preference to practice on Sunday mornings. Mr. Johnson and the conference have needed to schedule more games on Mondays because of official shortages and places to play. This has resulted in coaches feeling a Sunday practice is greatly needed. By WIAA rules, teams must have at least one day off a week, so that will still be in place. Mr. Johnson has spoken with neighboring districts, and some do allow for practices on Sundays however, they must be after a certain time of the day because of church services for families. Dr. White recommends that teams be able to practice on Sundays after 3:00 p.m. Coach Borgen talked to the board regarding his why's for wanting to practice on Sundays, specifically the mornings. Discussion followed. The board felt that if there is a game on Monday, a Sunday practice would be allowed if an athlete that is unable to attend is not penalized.
