VIII. Discussion

a. Discuss Budget Projections and the Need for a Potential Referendum

The budget forecast shows a deficit of one to two million dollars over the next five years. The model shows limited increase in general expenditures combined with rapidly decreasing general revenues due to declining enrollment and the funding formula. Reducing the budget by one to two million would result in significant elimination of positions, reduction in benefits, and an increase in class sizes. Making significant reductions that match the decline in revenues will have a tremendous negative impact on the quality of programming and services for the students of the

Williams Bay School District. Discussion followed regarding these projections and the need for a referendum.

b. Discuss Crisis Leave and/or Sick Leave Bank

The district previously had a sick leave bank but was advised by Brian Goodman, Boardman, and Clark attorney that the language was not IRS compliant. Attorney Goodman drafted the proposed language, but teacher representatives did not feel that language was acceptable as presented. Consequently, there is currently no language in the employee handbook or board policy when an employee does not have sick leave during a medical or crisis. The administrative team has explored language to support staff in times of catastrophic need or when an individual runs out of sick leave in an emergency. Discussion followed regarding this proposed handbook change to create a crisis leave/sick bank.
