I. Call to Order

J. Lothian called the meeting to order at 7:00 p.m. The Pledge of Allegiance was recited.

II. Communications & Public Comment - None

III. Student Presentation

Students Avery Kimmerly and Lauren Schnobel gave a presentation to the board regarding their internship with the Geneva Lake Chamber of Commerce.

IV. Reports

- A. Student Report Libby Anhold and Lacey Silverman updated the board on back-to-school events that were held, Homecoming, and Outdoor Education highlights as well as upcoming events being held in November.
- B. District Administrator Dr. White's items are covered in the agenda.
- C. Athletic Director / Sports Boosters Mr. Johnson updated the board on changes to the Sports Booster Club's awards night that is usually held at the end of the year. Based on feedback, going forward an awards night will be held after every season. He also mentioned that a bowling team has been formed through Delavan Lanes.

Lynette Vyhanek, the President of the PTO updated the board on the organization's activities.

D. Middle/High School Principal – Mrs. Soley-Johnson recapped student activities that happened since the last meeting, included Outdoor Education and student field trips. She

also highlighted that Williams Bay students saved \$30,434.36 though the transcripted credit program through Gateway Technical College.

- E. Elementary Principal Dr. Bond said that the elementary school has had a busy fall. She highlighted the elementary student council's food pantry drive and finalizing plans for the Veteran's Day Celebration on Friday, November 8.

B. Approve the 2024-2025 Budget

C. Set the 2024-2025 Tax Levy

Peyer motioned and seconded to resolve that a tax in the amount of \$10,012,740.00 be levied on all property, real and personal, which is taxable under State Tax Laws, within the boundaries of the Williams Bay School District for the 2024-2025 fiscal year, resulting in a tax rate of 0.00450. Motion carried.

D. Approve 2024-2025 Parent Transportation Contracts

M. Schneider/E. Nichols motioned and seconded to approve the 2024-2025 parent transportation contracts for forty-eight (48) private school students, as required by law, for a total cost of \$26,386.08. Motion carried 5-0.

E. Discuss Dr. White's Annual Performance Evaluation & Set Date/Time for Closed Session Discussion

VI. Discussion Items

A. Discuss Policy 751.3 – Use of Private Vehicles & District-Owned Vehicles on School Business

Dr. White reported that state law requires a physical for any employee driving a vehicle. This was added to the policy language along with an explanation of when the van is required to be driven and when an employee may receive mileage reimbursement.

B. Discuss Policy 529- Staff Use of Social Media

Dr. White reported this is a new policy for consideration and it has been shared with staff for their feedback.

C. Discuss 2024-2025 Strategic Plan

Dr. White reported that he worked with the administration team to revise the strategic plan. The changes condense the plan and realign it with the goals established by the SAIL team.

D. Discuss December Board Meeting Time Change

Dr. White reported that the Village Administrator requested to hold a joint Planning Commission/Village Board Meeting at the school to discuss the George Williams/Topography development.
