I. CALL TO ORDER

Vice President D. Ripple called the meeting to order at 6:59 pm. The Pledge of Allegiance was said.

II. COMMUNICATION AND PUBLIC COMMENTS

III. REPORTS

- A. Student Representatives –B. Thompson and L. Judd reported that the Math team is competing tonight at the Conference Math Meet. The Collage Concert will be held on May 6th. Prom is being held at Geneva National on May 4th. The high school Academic Bowl was held, and our team placed second. The senior trip was held the week before spring break and went well. The weather was great and the Seniors were able to take a lot of tours. Student Council will be holding a dog food drive the end of April or beginning of May to benefit the Hoover House. More details will be available when they are finalized. On April 23rd there will be an Open Mic night. This will benefit the band and choir trip that will take place next year. Mrs. Kavanagh received a grant from Kohls for a field trip and is looking at possible destinations in Milwaukee and Chicago. D. Approve TAG (Talented and Gifted) Coordinators Salary for 2018-2019

K Granberg/K. Nelson motion and second to make the compensation for the Talented and Gifted (TAG) Coordinators' position \$2,750 starting with the 2018-2019 school year, carried 4-0.

D Ripple would like to try to avoid having to change compensation mid-year and asked what will be changed in future roll-outs. Dr. Anderson stated that when a change is made, each person will be made aware of the change and the reasons behind the change personally.

V. DISCUSSION ITEMS

A. History Club Presentation

Mrs. Soplanda and members of the History Club gave a presentation familiarizing the board with the club. The Williams Bay History Club was formed in 2000 and has grown to over 100 members, which makes it the largest club in the high school. In the last 10 years, the club has been named one of the top history clubs in the nation three times and Mrs. Soplanda has been awarded the top History Club advisor. The club is service driven and is involved in over 30 community service projects, the biggest being the restoration of Frost Park. The club does their own fundraising for their activities and is able to give the Adam Huber History Club Scholarship to an outstanding graduating member. The club also participates in field trips and History Bowls, where they have been very successful.

B. 2019-2020 Budget Update

Dr. Anderson gave an update on the 2019-2020 budget, noting that a more detailed discussion will take place at the next Board work session. In working with the budget, the administrators have been very conservative as there are big unknowns with the Governor's budget. For staffing, there will be three sections of each grade level at the elementary and one new position added. At the high school, the budget will allow for an additional staff member. Dr. Anderson and C. Reynolds have put together the district and maintenance budgets. The staff has filled out their requests and turned those into their building principals. Dr. Anderson hopes to have a first draft to present to the board at the June meeting. Discussion followed.

C. Discuss policy #235 – Director of Student Services job description

Currently, K. McOmber is the Director of Special Education. In the future, she may grow and expand her duties and the Director of Student Services would be her job description at this time. Currently, she works 100% within the special education realm, which makes a percentage of her salary able to be reimbursed by aid. If her duties would expand, this would change. She currently completes most of the items on this new job description already and if she becomes over-whelmed, there are items that she will be able to shuffle to other members of the Student Services team.

D. Discuss Policy #542.1 – Special Education Paraprofessional /Aide job description

Dr. Anderson presented this job description as a first draft for review. Action will be taken at the May Board of Education Meeting.
